President's Comments

- As we have all seen in the news subdivisions in general have seen groups checking for unlocked vehicles and stealing items. These are organized groups. If you see this type of activity, please report it immediately to the St. Peters Police. This past year there have been two reported vehicle thefts from the subdivision. Both vehicles were recovered, one in Hazelwood and the other in St. Louis, one had heavy damage. Keeping vehicles locked with no visible items and garage doors shut is a deterrent to this.
- There will need to be some refresh work on the entrances. The ones on Willott have bushes that have grown to obscure the entrance signs and other entrances have bushes in need of replacement. For the Athens Drive basin, the city is looking at replacing the temporary fence and the plantings in the basin that have drawn much criticism. This last year in the common drainage area within the subdivision we had to remove several trees due to Emerald Ash borer infestation. We will review the condition of the remaining trees.
- With the increased purchase of houses for rental purposes we are considering amending the restrictions to place limits on the percentage of rental houses allowed. We would like resident owners input on this.
- If you have a particular area with street damage, please bring it to the attention of the city and report it to the subdivision HOA. This past winter has produced potholes and pavement damage that we want to see repaired.
