- **URGENT NEED!** Paul Diamond, who has served as Treasurer for quite a few years has decided to move on from the position. We must have a candidate for this position. Without a Treasurer we cannot continue to maintain the entrances and common ground areas we are responsible for. The covenants require three Trustees. We need a homeowner to for this. Duties include providing first or second approvals on expenditures, monitoring our account with City & Village, preparation of the summary spreadsheet for our annual report and meeting or talking with residents when needed. - This year we will be attempting to amend the covenants to add limitations on the number of houses that can be rental units. Over the past two years investment companies have been buying up houses in subdivisions as rental property. This change would not affect any current rental houses but would put a cap on the percentage of houses that can be rental property. Many subdivisions have added this and most of the newer ones include this in their covenants. The subdivision is intended as a residential area not a commercial rental one. To make this change we will need a positive vote from 2/3 of the homeowners. This will be a tough task to accomplish and will require canvasing by volunteers.
